

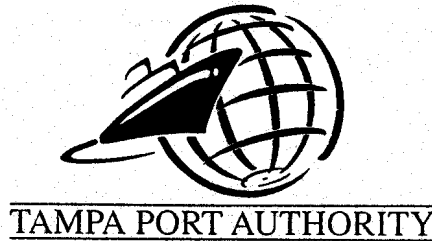

**TAMPA PORT AUTHORITY PERMIT STIPULATIONS**  
**STANDARD WORK PERMIT NO. 00-079**

**SPECIFIC STIPULATIONS:**

**June 21, 2000**

1. This Permit authorizes alterations to Archie Creek only as depicted in the permit exhibits and stipulations. Any jurisdictional modification of the project design will require prior authorization by the Tampa Port Authority.
2. The permittee must comply with all conditions of the Hillsborough County Environmental Protection Commission Review Letter (Exhibit A-26.)

### **TAMPA PORT AUTHORITY GENERAL PERMIT STIPULATIONS:**

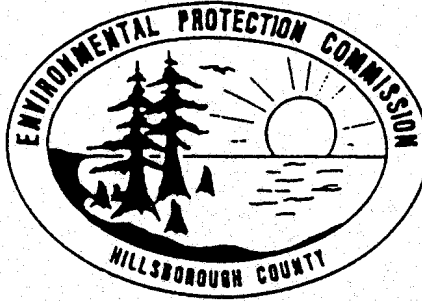
1. The proposed work shall be done in accordance with the approved drawings attached hereto as Exhibit A.
2. The Permittee shall notify the Tampa Port Authority when work under this permit is initiated and shall further notify the Tampa Port Authority when work under this permit has been completed. The Tampa Port Authority reserves the right to inspect all work conducted pursuant to this permit to insure compliance with these stipulations.
3. The enclosed Permit Card must be conspicuously displayed at the project site once work on this project has been initiated and shall remain so displayed until the project has been completed. Within fifteen (15) days of completion of this project, the Permit Card must be returned to the Authority.
4. All work shall be accomplished so as to minimize the dispersion of silt and debris and the destruction of marine resources in public waters. All applicable water quality standards shall be maintained. Silt barriers will be employed, if necessary, to accomplish this.
5. The proposed work shall be done so as to prevent interference with the riparian or property rights of the adjacent property owners. This permit authorizes no invasion of private property or rights in property.
6. This permit conveys no title to land or water, and does not alter in any way the legal riparian rights of the Permittee. Issuance of this permit does not constitute a binding determination of riparian boundaries, lines or rights.
7. This permit does not relieve the Permittee from the requirement of permits from the U. S. Army Corps of Engineers, the State of Florida, the Hillsborough County Department of Development Coordination, and/or other applicable agencies.
8. The Permittee, in accepting this permit, agrees to comply with the provisions and conditions herein and assumes all responsibilities and liability and agrees to hold the Tampa Port Authority harmless from any and all claims of damage arising out of operations conducted pursuant to this permit.
9. The Permittee shall operate and maintain the authorized structure in such a manner so as to prevent the creation of any navigation hazards, unauthorized source of air or water pollution, hazard to public health and safety, or so as to unduly interfere with the public's use of the waterway.
10. Should the Permittee fail to comply with the stipulations of this permit, should a situation arise wherein it would be in the public interest, the Tampa Port Authority reserves the right to revoke this permit upon written notice to the Permittee.
11. This permit does not relieve the Permittee from the requirements of any applicable deed restrictions.
12. Construction materials, debris, or other trash will not be allowed to escape into the water, at anytime. Such materials are to be disposed of in an approved manner, i.e., upland disposal facility, appropriate trash receptacles, etc.

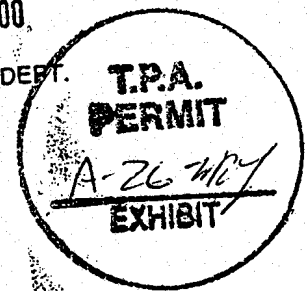

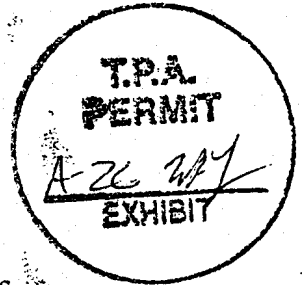
Dear Mr. Linton:

An environmental review has been completed for the above-described project by the staff of the Environmental Protection Commission. The EPC recommends approval of the proposed project and offers the following comments:

1. EPC staff will not object to the location or dimension of the activities in Archie Creek as proposed within the submitted application.
2. EPC staff is also reviewing the Cargill gypsum stack expansion project as a participant in the Ecosystem Team Permitting process. Please note that this approval of the Tampa Port Authority's permit does not provide reliance for an approval, by EPC staff, of the Florida Department of Environmental Protection's Ecosystem Team Permit.
3. All efforts must be undertaken to prevent any erosion or turbid water from being discharged into wetlands and/or waters of the County. Turbid discharges that exceed 50 JTU's (Jackson Turbidity Units) or 29 NTU's (Nephelometric Turbidity Units) above background levels are a violation pursuant to Chapter 1-5, the EPC Water Quality Rule. The erosion or discharge of sediments into wetlands is a violation of Chapter 1-11, the EPC Wetland Rule. Hay bales, silt screens or other EPC approved methods or erosion/turbidity control may be required. It is the responsibility of the owner/developer to insure the installation of adequate erosion control barriers prior to the commencement of any site work.

These erosion control devices must be maintained in good condition throughout the construction process and until all loose soils have stabilized. It is strongly recommended that all erosion control devices be regularly inspected during construction and modified if conditions warrant.



#### INFORMATIONAL COMMENTS

Please be advised that this approval applies only to the development proposal as submitted, and in no way does it provide EPC approval to any other aspect of the EPC review process. In addition, this approval does not imply exemption from obtaining all proper permits from other governmental agencies. Please note that this is only a recommendation, the actual permit will be issued by the Tampa Port Authority.

Any activity interfering with the integrity of wetland(s), such as clearing, excavating, draining or filling, without written authorization from the Executive Director of the EPC or his authorized agent, pursuant to Section 1-11.07, Rules of the Commission, would be a violation of Section 17 of the Environmental Protection Act of Hillsborough County, Chapter 84-446, and of Chapter 1-11, Rules of the EPC.
